TO SAVE CORAL REEFS DURING AN ERA OF RAPID ENVIRONMENTAL CHANGE, CORAL IS ADVANCING A SCIENCE-BASED STRATEGY TO HELP CORALS ADAPT TO CHANGING CONDITIONS. IN PARTNERSHIP WITH RESEARCHERS AT THE UNIVERSITY OF WASHINGTON AND RUTGERS UNIVERSITY, WE HAVE LAUNCHED A PROJECT TO DESCRIBE HOW VARIATION IN THE DIVERSITY AND CONNECTIVITY OF REEF-BUILDING CORALS AFFECTS THEIR POTENTIAL TO SUCCESSFULLY ADAPT TO ENVIRONMENTAL CHANGE. TO PROTECT REEF HEALTH THROUGHOUT THE HAWAIIAN ISLANDS, CORAL WORKS TO IMPROVE WATER QUALITY BY REDUCING LAND-BASED SOURCES OF POLLUTION, INCLUDING FROM POORLY TREATED WASTEWATER AND RUN-OFF FROM LAND. CORAL WORKS TO ADDRESS A VARIETY OF STRESSORS TO CORAL REEFS IN HONDURAS THROUGH THE ESTABLISHMENT OF MARINE PROTECTED AREAS (MPA) AND BY IMPLEMENTING WATER QUALITY IMPROVEMENT PROJECTS.

IN 2017, CORAL MADE SIGNIFICANT PROGRESS TOWARD IMPROVING COASTAL WATER QUALITY ON THE ISLAND OF ROATAN. IN THE COMMUNITY OF WEST END, WE HAVE CONNECTED 249 OF A TOTAL 379 HOMES IN THE COMMUNITY, THEREBY REDUCING THE AMOUNT OF RAW SEWAGE DISCHARGED INTO THE ENVIRONMENT BY AN ESTIMATED 25.2 MILLION GALLONS PER YEAR. WATER QUALITY MONITORING IN THE WEST END HAS FOUND A 30 PERCENT REDUCTION IN THE OCCURRENCE OF ENTEROCOCCUS, A BIOLOGICAL PATHOGEN FOUND IN SEWAGE. WE EXPECT THESE TRAJECTORIES OF IMPROVEMENT TO INCREASE AS MORE HOMES ARE CONNECTED.
